A. Shelter Services:

The following illustrates the number of positive outcomes of shelter pets during the month of February 2020 (family adoptions, pets rescued, reclaimed by their owners, TNR program, and pets transferred to pet adoption centers).

During this month, Animal Services staff assisted **2,847** visitors at the Animal Shelter.

During this month, the Animal Rescue Coordinator helped perform temperament testing on 109 dogs along with facilitating the transfer to our rescue partners the following 9 pets (dogs & cats) with a variety of medical conditions or special needs:

B. Field Services:

Field Services operates on a 7 day, 24 hour calls for service model based on level of priority on all calls received. Six Animal Control Officers, one Animal License Inspector and one Field Services Supervisor currently serve the City.

Animal Control Officers rotate daily for Night Truck assignment in response to high priority calls after hours. During normal business hours, Animal Control Officers respond to routine and high priority service requests. The Animal License Inspector canvasses the community educating residents of the legal requirement to have all dogs currently vaccinated against rabies and to maintain current dog licenses.
