



National Animal Shelter & Rescue Appreciation Week

During the week of November 7—11, the Moreno Valley Animal Shelter participated in the National Animal Shelter and Rescue Appreciation Week. This recognition highlights the important work performed by Animal Shelter staff and many of the animal rescue partners and many other individuals in the rescue community who work tirelessly to provide homeless pets a life-long loving home. The week was kicked off by a weeklong adoption event along with a low cost rabies vaccination and microchipping clinic on Saturday, November 11th. During the pet adoption event, 54 pets were adopted along with nine pets that were reunited with their families

Low-Cost Rabies Vaccination & Low-Cost Microchipping Clinic Results

On Saturday, November 11, 2017 the Animal Shelter held a low cost rabies vaccination and dog licensing clinic at the Animal Shelter. Dog and cat owners took advantage of the reduced pet vaccination fees along with being able to renew or purchase their dog's license as well as purchase a HomeAgain microchip for only \$10.

Home for the Holidays Pet Adoption Event Results

During Home for the Holidays Pet Adoption Event held at the Animal Shelter on November 14—18, 56 pets were adopted along with 14 dogs that were reunited with their families. Discounted adoption fees were all-inclusive (\$50 for dogs & \$15 for cats) covering the spay-neuter surgery, a HomeAgain microchip and vaccinations.


Trap, Neuter, Release (TNR) Program Update

During the month of November, twenty-nine feral cats were altered and returned to the field. The goal of the program is to reduce the over-population of feral cats within the community. Since inception of the TNR program over three years ago, over 1,000 feral cats have been saved from being euthanized. Feral cats that are removed from areas in close proximity to schools and businesses are not selected as TNR candidates but do remain available to interested animal rescue organizations.

Administration

First Nandina





The First Nandina project was approved by the Planning Commission in October, 2014. Demolition of the existing structures on the site was completed in April, 2016 and grading began this year. The project is a 1.45 million square foot warehouse/distribution center on 73 acres located at the southwest corner of Heacock Street and Nandina Avenue in the Moreno Valley Industrial Area. The developer, First Industrial Properties, has received strong interest from potential tenants prompting proposed modifications to add additional truck parking on the site. The Building permit was issued on October 11.

Prologis

The 601,810 square foot Prologis industrial building on the corner of Graham Street and Brodiaea Avenue has been issued a building permit and construction is nearing completion. Residents can look to the East from City Hall for a view of the construction.

Prologis Eucalyptus Industrial Park

Prologis, a leading industrial developer, has started work on its entitled project on Eucalyptus Avenue, east of the Moreno Valley Auto Mall. This new development (currently in permit plan review) will introduce four new industrial tilt-up buildings ranging from 163,423 square feet up to 779,236 square feet. The development, which encompasses approximately 110 acres of land, has already generated significant interest from the business world. Solaris Paper, a U.S.-based manufacturer of premium quality kitchen, bath, and facial tissue, has selected this site to relocate its operations and has committed to occupy the largest building.

Projects

- Building permits have now been issued and construction has commenced on a 104 guest room Holiday
 Inn Express and a multi-tenant retail building at the northeast corner of Day and Eucalyptus, the former
 site of Robertson's Ready Mix. These are the first submittals for "The "Quarter" project, which will
 eventually include a fast-food restaurant, and a second retail/restaurant building. Leases have been
 signed by both Fat Burger and Z-Pizza to occupy spaces in the center.
- Building permits have now been issued and construction has commenced on the new "Residence Inn," a new 4-story hotel with 112 guestrooms and outdoor patios, which is the second building in "The Quarter" project.
- The Cactus Commerce Center, to be located at Cactus Avenue and Commerce Center Drive, has submitted plans for a 37,000 square foot warehouse building. The first phase of the project will include a diesel and gas station, car wash, and drive-through restaurant. Future submittals to complete the project will include two additional restaurant pads and a small industrial building.
- A building permit has been issued and construction is now in progress on the new "Habit Burger"
 located in the Towngate Promenade. This business, poised to open next to Café Rio Mexican Grill, will
 bring in another selection of places to dine within this thriving shopping complex.
- Café Rio has obtained a Certificate of Occupancy and is now open for business. Café Rio, a Mexican
 restaurant with a unique flair, is a great new addition to the restaurants located near and within the
 Towngate Promenade.
- Permits have been issued and work is underway on a new speculative industrial shell building at Nandina and Hemlock Avenues. "Nandina A," a 793,903 square foot tilt-up building, is the latest in industrial structures attracting new business to Moreno Valley's growing industrial sector.
- Permits have been issued and work is underway on the new Nandina Logistics Center, a new 1,388,210 industrial building, including trash enclosures, light standards, auto and trailer parking, and a pump house.
- International House of Pancakes is now open for business! Building permits have been finalized and a
 Certificate of Occupancy was issued for this new business just in time for the Veterans Day Holiday.
 This well-known breakfast chain is located in the building originally occupied by Fitness 19, within Iris
 Plaza.
- Building permits have been issued and construction is underway on the new model homes belonging to KB Home's Daybreak development. The development will include 104 new residential units in northern Moreno Valley in the Sunnymead Ranch Parkway area.
- Sares-Regis has obtained permits and construction is underway on a 736,497 square foot expansion of warehouse space to the existing Deckers building on Perris Boulevard. The expansion will also incorporate 3,461 square feet of new office space.

Advertising: Economic Development actively promotes the City of Moreno Valley as the premier destination to do business in southern California. EDD coordinated 74 ad placements with 31 trusted industry publications. Moreno Valley's business advertising had an estimated reach of more than 1.1 million in 2017. The intent of these ad placements is to market Moreno Valley to a wide variety of site selectors, developers, corporate decision makers, international and Fortune 500 companies in a variety of industries including retail, industrial, e-commerce, restaurants, real estate development, medical, and health & wellness.

Proactive email campaign: Throughout the year, Economic Development conducted 82 email campaigns to attract new businesses in the aerospace, automotive, commercial, industrial, restaurant, space, medical device manufacturing, medical, and various industries.

Workforce Development: Developed strategic partnerships with California Baptist University (CBU), Moreno Valley College (MVC), University of California Riverside Anderson School of Business (UCR), Moreno Valley Unified School District / Moreno Valley Adult School, the Moreno Valley Youth Opportunity Center (YOC), the March Joint Powers Authority's MARS Initiative, and the Inland Empire Economic Partnership (IEEP) to establish training programs to prepare Moreno Valley's workers for careers in local growth industries.

Unemployment in Moreno Valley has declined significantly since it peaked at 17.5% in 2010 to 5.4%. The latest information from the California Employment Development Department (EDD) indicates that unemployment in Moreno Valley and throughout Riverside County continues to decline, which is on par with seasonal trends.

Home Resale Market

Home sales information from CoreLogic (<u>www.corelogic.com</u>) indicates that Moreno Valley's average home resale volume and the home resale value both experienced an increase.



Financial Resources Division

Moreno Valley's HireMoVal

The City's HireMoVal program has kicked into gear four months after it started. Two applications are being processed and another 20 are expected to be processed in the near future. The HireMoval's first year began on July 1, 2017 and will run through June 30, 2018. The city has budgeted \$50,000 for this year's program.

Time and Materials (T&M) Program

The City's Time & Materials program was created to provide qualifying large-scale development programs the convenience and economies of scale option deposit account to fund staff time and material costs of project development. Work is performed by each of the development services divisions: Building & Safety, Fire Prevention, Land Development, Parks, Planning, Special Districts and Transportation. Both time of staff and materials used or outsourced services are tracked and reimbursed by the developers as services are rendered. Developers are provided a monthly report of activity and deposit accounts are replenished as needed. Our active T&M Projects, including the projects that are in the warranty phase are listed on the next page.

Financial Operations Division

Affordable Housing Compliance Monitoring has an Impact

Over the last ten months, we have completed our annual affordable housing compliance monitoring by reviewing current compliance data and working directly with approximately 25 multi-family property owners and/or managers to bring current units into compliance for over 1,200 affordable units within the City limits. Upon initial inspection, 95% of tenant files were found to be in compliance. This is a significant improvement over the last year's findings, where only 63% of tenant files were in compliance. Our consultant, RSG, has worked directly with property owners and/or managers to bring current units into compliance while providing the City with monthly compliance status reports for all subject properties. RSG provided property owners/managers with a minimum of 30-days' notice to bring units into compliance. Upon re-inspection, 99% of inspected units passed established minimum file



requirements. In addition, Rent Rolls and Owners Compliance Reports were analyzed by RSG to determine if the rent calculations complied with the applicable rent limits and income requirements for very low income households as set forth by U.S. Department of Housing and Urban Development ("HUD") and California Departments of Housing and Community Development ("HCD") guidelines. Three projects were found to be in non-compliance. RSG is working with respective project owners/managers to bring units into compliance. RSG fully expects owners to be in compliance by next inspection.

Fire Department

Office of Emergency Management

In November, the Office of Emergency Management and the City's Technology Services Division worked collaboratively to complete an update to the City's WebEOC system. WebEOC is an Internet-based collaborative communications system that provides for information and resource tracking, situation analysis, and dissemination of information during Emergency Operation Center (EOC) and/or Department Operations Center (DOC) activations and exercises. The City's WebEOC allows us to see road closures, care and shelter facilities, animal shelters, school status, incident activities or information.

Andrew Cheng, Program Specialist, and volunteers from our Emergency Response Force (ERF) hosted Fire Extinguisher Training for Rancho Verde High School Students on November 9, 2017. The class consisted of 260 students. The students participated in a hands-on extinguisher course utilizing a live fire extinguishing system and water-based training extinguishers. Students were also provided with instruction on basic fire chemistry, the different classifications of fire, fire prevention and mitigation strategies, and the necessary steps to extinguish a small fire.



Zuzzette Bricker, Emergency Management Program Manager attended the International Association of



Emergency Managers (IAEM) Conference. IAEM has more than 6,000 members worldwide and is considered the preeminent international non-profit organization of emergency management professionals. The IAEM Annual Conference provides one of the best opportunities each year to connect with forward-thinking practitioners and take home new approaches to problems. This year's IAEM conference provided critical information on current emergency management trends and emerging threats, such as the active shooter in Las Vegas. The IAEM Annual Conference provided connections to the nation's key

emergency management leadership and offered training in latest front line issues.

Fire Operations

On November 4, Engine 6 responded to a report of a resident with respiratory difficulty in District 2. Upon arrival, the patient was observed with severe difficulty breathing, pursed lip breathing, and only speaking in one word sentences. Firefighter Paramedics began immediate Advanced Life Support care (ALS) including Continuous Positive Airway Pressure (CPAP) device, Intravenous therapy, respiratory medication, and a calming medication. During treatment the patient's oxygen saturation came up from 88% to 100%. The patient was transported by AMR with Fire Department Paramedics maintaining patient care. While transporting to the hospital the patient's condition continued to improve. Patient care was transferred to emergency room staff for continued care.

On November 15, Engine 91 responded to a reported auto versus pedestrian accident in District 4. Upon arrival, Firefighter Paramedics located the patient with Police and School Staff on scene. The patient sustained minor to moderate injuries and was initially combative, but calmed down shortly after Firefighter's arrived. Firefighter Paramedics rode with AMR to maintaining patient care while enroute to Riverside University Health Systems (RUHS).

On November 16, Engine 2 and Truck 2 responded to an unconscious, unresponsive elderly male in District 3. Upon arrival, Firefighter Paramedics found the 81 year old male in cardiac arrest and immediately imitated high quality cardio pulmonary resuscitation (CRP) and administered Advance Life Support (ALS) treatment. The patient had a return of spontaneous circulation (ROSC) while on scene, and was immediately loaded for transported by AMR to Riverside University Health System's (RUHS) Emergency Room with two Firefighter Paramedics maintaining patient care.

On November 18, Medic Squad 6 responded to a call in District 1. Upon arrival, Firefighter Paramedics found a 55 year old female lying on her stomach on the floor of her bedroom. She had been actively seizing for close to 12 minutes. The patient's face was turning blue due to lack of oxygen. Quick and aggressive action by Firefighter Paramedics helped the patient recover and improve her vital signs. Firefighter paramedics quickly placed the patient on oxygen, started an IV and gave her anti-seizure medication. The patient was quickly transported to the hospital. Patient care was transferred to emergency room staff.

On November 23, Engine 6 responded a reported Traffic Collision with possible fatalities in District 1. Upon arrival, Firefighter Paramedics found a male patient lying on his back in the bushes. The patient had been involved in a single vehicle high speed roll over off the side of the freeway. He was ejected and was found approximately 200 feet from his vehicle, and multiple bottles of alcohol were found in and around the vehicle. The patient suffered a blunt trauma full arrest and was pronounced dead on arrival. There were no other patients or vehicles involved. The incident was turned over to California Highway Patrol (CHP).

Police Department

Case of the Month

Over the last three months, several fire stations were burglarized while fire personnel were dispatched to emergency calls for service. Fire station property as well as personal property was taken during the burglary. On November 14, 2017, the Special Enforcement Team was investigating the burglary when they learned the suspect was attempting to sell the stolen property on a website. Officers contacted the suspect who agreed to sell them the stolen property. Officers met with the suspect and he was detained without incident. Officers searched the suspect's residence and recovered most of the stolen property. The suspect was booked at the jail for burglary.

Patrol

Patrol officers responded to 14,386 calls for service in November.

On November 7, 2017, patrol officers learned that several juveniles were loitering in a park during school hours. As officers approached the juveniles, one juvenile tossed a handgun in the bushes. The juvenile was arrested for possession of a firearm.

Community Services Unit

The Community Services Unit (CSU) participated in three explorer meetings, one reserve meeting, two neighborhood watch meeting, one volunteer meeting, and one community zone meeting.

On November 2, 2017, members of the Moreno Valley Police Department donated items valued at \$274,536.43 to the "Stuff the Bus" event. "Stuff the Bus" is run by Operation Safe House in cooperation with the Riverside Transit Authority (RTA). Operation Safe House operates two short-term emergency shelters for juveniles in Riverside County. Often juveniles who enter the safe house program have only the clothes on their backs, and the safe house is tasked with providing them everything they need to return to a normal life.

The Donated items were collected over the past few months from various members and organizations within the Moreno Valley community. The Moreno Valley Police Department is grateful to everyone who helped out and donated to this event.

Volunteers

The Moreno Valley Police Department relies heavily on volunteer forces to assist with providing valued service to the residents of Moreno Valley. During the month of June, volunteers provided over 1,080 hours of service to the Moreno Valley Police Department. Volunteers conducted Citizen Patrols, assisted the Business Office assisted with incident call outs, assisted with city events, and assisted with monitoring the City Wide Camera System.

Traffic Team

Office of Traffic and Safety Grant Operations

During the month of November, the MVPD Traffic team conducted an Office of Transportation and Safety (OTS) directed enforcement operation consisting of one DUI Saturation Patrol, DUI/Driver License Checkpoint, one DUI Saturation Patrol, one "Know Your Limit" Education and Awareness Program, three Primary Collision Factor Enforcement Operations, and two Pedestrian Safety Enforcement Operations.

Traffic Stops/Citations Issued

The MVPD Traffic Team conducted 958 vehicle stops, issued 871 hazardous/moving violation citations, 64 non-hazardous violation citations, and 48 parking citations. In addition, the team arrested 31 persons for driving under the influence of alcohol/drugs (three involved a traffic collision), and made 82 misdemeanor arrests, and eight felony arrest.

Traffic Collisions

The MVPD Traffic Team responded to 1 fatal collision, 5 major-injury collisions, 56 minor-injury collisions, 32 non-injury property damage only collisions, 5 injury hit and run collisions, and 97 non-injury hit and run collisions. In addition, the MVPD Traffic Team responded to 47 reckless driver calls, 27 traffic hazard calls, 59 abandoned vehicle calls, and 10 disabled vehicle calls.

Special Enforcement Team

This multi-focus team consists of the MVPD Gang Team, Narcotic Enforcement Team, Problem Oriented Policing Team, and Burglary and Robbery Suppression Team. During the month of November, the Special Enforcement Team served 13 search warrants, made 42 felony arrests, and 24 misdemeanor arrests.

Investigation Bureau

The MVPD Investigations Bureau investigated 130 crimes related to a variety of property and person's crimes. The Investigations Bureau authored and served six search warrants, arrested one suspect, and filed seven cases with the District Attorney's Office. In addition, detectives interviewed 88 individuals required to register as sex registrants and conducted 4 business license compliance checks.

Public Works Department

Capital Projects

Alessandro Boulevard/Elsworth Street Intersection Improvement

The contractor has installed the new traffic signal poles and transferred the equipment, including camera and emergency vehicle preemption systems. The old signal poles that were in the Alessandro medians have been removed. The final work will consist of grinding and paving the intersection, finishing the remaining sidewalk panels, and striping. It's anticipated that the construction should be completed by early January 2018 (weather permitting).





Hubbard Street Storm Drain from Ironwood Avenue to Kalmia Avenue

The construction of the Hubbard Street Storm Drain continues into the month of December. This project is ahead of schedule. The contractor has completed installing the storm drain main line in Hubbard Street between Ironwood Avenue and Kalmia Avenue. The contractor will continue with the installation of catch basins and connector pipes to complete the storm drain system. Next, the contractor will install curbs and gutters at the locations where they currently do not exist and restore street pavement. It's anticipated that the construction will be completed by end of February (weather permitting).





Maintenance & Operations

Adopt-A-Road and Sponsor-a-Street Programs Officially Launch

Moreno Valley officially launched the Adopt-A-Road and Sponsor-a-Street Programs to fight litter and *Keep Moreno Valley Beautiful*. These programs are expected to become a prominent component of the City's *Keep Moreno Valley Beautiful* initiative. The City is giving companies and organizations the opportunity to support well-maintained and attractive roadways in throughout Moreno Valley. Don's Auto Center is one of the first businesses to sponsor a segment of roadway. Fifteen businesses have already expressed interest in the Sponsor-a-Street Program. The Emerging Leader's Council is one of the first volunteer groups to adopt a segment of roadway. Seven volunteer groups have expressed interest in the Adopt-a-Road program. Parks & Community Services Department

Community Events

• The City of Moreno Valley hosted the second annual CycloCross race on December 16-17 from 8 a.m. to 3 p.m. at March Field Park. The City partnered with Southern California CycloCross to coordinate and construct a 1.8 mile custom course. CycloCross combines road racing and mountain biking while challenging riders with a course featuring grass, sand, gravel, and dirt mounds. Riders must negotiate a number of obstacles that may force them to dismount and remount their bikes to continue the race.

 The Snow Day and Tree Lighting Ceremony was a great success with more than 3,500 attending. The event was held at the Conference and Recreation Center on December 2nd. At Snow Day, participants enjoyed playing in real snow, food vendors,



performances, craft vendors, and music. Later in the evening, residents enjoyed the Tree Lighting Ceremony which was kicked-off with the lighting of the "M" on Box Springs



Mountain. The Tree Lighting Ceremony was hosted by Mayor Yxstian Gutierrez and featured a presentation of colors, the national anthem, the Moreno Valley City Council. and a visit from Santa Clause. Preceding the event, Moreno Valley's Master Chorale performed holiday songs and announced the snowman contest winner. After the

conclusion of the ceremony residents were invited to enjoy Santa's Workshop. This winter wonderland included fun games, holiday crafts, face painting, miniature golf, balloon art, and pictures with Santa.

• The *Winter Contract Class Performance* is favorite event of parents and participants alike. The Winter Performance highlights the growing diversity of classes offered by the Parks and Community Services Department including multiple styles of dance, martial arts demonstrations, and musical performances.

Special Events Permits

The Remnant of Life Worship Center held a *Community Turkey Bowl* event at Lasselle Sports Park, which served more than 400 people with a free Thanksgiving meal, along with providing approximately 45 haircuts and 147 care packages. Many exciting prizes were also donated to participants of this event.

Community Services

Recreation Programs

Several new recreation classes will be added this winter and spring season including:

- **Art Expression**: This is a four-week class for children ages 4-10. Young artists will learn basic tools and techniques to express themselves through the world of art. Students will learn expression through painting, graphite work, mixed media, and more!
- Into Art Fundamentals: This is a four-week class for children 5-12. This is an Introduction to drawing and a prerequisite to all art classes. This class is designed to teach basic art and design fundamentals including line, shape, color, texture, and composition. This entry level class introduces children to color wheel, mixing colors/textures, drawing techniques and how to use various drawing materials. Students explore different mediums and will embark on a journey of art appreciation.
- **Physical and Mental Self-Defense:** This is a four-week class for ages 7 and older. This self-defense class will empower participants with security, balance, and strength as well as internal clarity, serenity, and peace.

- **Spanish for Work and Recreation:** This is a four-week class for ages 18 and older. Students will create and participate in role playing scenarios and environments using Spanish that mimics real life work or leisure related conversations and activities that you encounter in everyday life.
- **Spanish Guitar and Singing:** This is a four-week class for ages 7 and older. Learn chords, finger exercises, practice vocalizations, and learn songs such as Rancheras, Romanticas, Bossa Nova, Flamenco and more!

The *Time for Tots* winter break is quickly approaching and teachers have been reviewing everything that the children have learned since the beginning of the school year such as letters, numbers, shapes, colors, and other educational material. The students had an assessment before break so parents are aware of their child's progress. Teachers celebrated the holidays with a mini Winter Celebration, which on December 14th. Santa visited each classroom and brought candy canes for all the students. Tots also enjoyed pajama day, which consisted of a holiday potluck and a movie.



The *Valley Kids Winter Camps* was held December 18th through January 5th at March Field Park Community Center (children ages 5-11) and the March Annex (teens ages 12-14). The participants will enjoyed a variety of winter-themed art projects, games, sports, dance, and other supervised activities in a fun-filled environment. Children had the opportunity to enjoy activities such as holiday movies, special activities, and edible crafts.

Sports Programs

- The *Pee Wee Junior Soccer Program* begins January 8th. Participants between the ages of 3 and 7 will learn the fundamentals of soccer in a fast-paced, fun filled environment.
- The fall/winter season of the *Adult Softball League* is underway. More than 200 participants make up the coed and men's divisions this season.
- The *Winter Youth Basketball League* practices are underway. The season will start with a holiday tournament on January 5th and 6th. This program is geared towards learning basic skills, exercise, meeting new friends, and having fun.
- Registration has started for the *Adult Volleyball Tournament*. The tournament is set to take place this month.
- *Open play sports* are offered nightly at various locations for community members and athletes of all ages and skill levels. The open play sports allow community members to stay active by participating in recreational activities at their leisure. Park Ranger Statistics


Park Rangers patrolled 1,288 areas, had 3,082 public contacts, and issued 191 citations such as curfew violations, vandalism, parking, and alcohol.
