#### **RECOMMENDED ACTION**

#### **Recommendations: That the City Council:**

1. Consider, and if desired, by majority approve the proposed Resolution of the City Council of the City of Moreno Valley, California, Adding "Governmental Agency Employer" to the Conflict of Interest and Disclosure Subsection of the Rules of Procedure for Council Meetings and Related Functions and Activities.

#### **SUMMARY**

This report presents proposed changes to the City Council Rules of Procedure, which if adopted would require disclosure of employment with a public entity prior to consideration of any item involving such entity.

#### DISCUSSION

This staff report is being presented based on a request of two Council Members and as a follow up to the item presented to City Council at the meeting of September 20<sup>th</sup> by the Interim City Attorney.

Under current Council Rules of Procedure, Section 5.5.5.1 mandates compliance with applicable State laws with respect to Conflict of Interest disclosures. Among those is a requirement that a Council Member recuse her/himself from participation in any item materially affecting any source **of income** of that Council Member (Gov. Code Section 87103(c)). That provision, would for example, require recusal if the decision would have material effect on that Council Member's employer.

State law in Gov. Code Section 82030(b)(2), exempts any salary or reimbursements received from a Federal, State or local governmental agency, from the definition of

**income** as applied in the Conflict of Interest provisions above. Practically it exempts any Council Member employed by another governmental agency from mandatory recusal on an item under Council's consideration that may have material effect on that agency.

The proposed Resolution in order to increase transparency of City Council's actions would amend the current policy to add a requirement of disclosure in an instance where a Council Member is employed by a governmental agency and an item before the Council would result in a material effect on that agency. If adopted it would require a Council Member to announce that she/he is an employee of a given public agency that has an item before the Council for consideration. The change in policy would not require recusal.

#### **ALTERNATIVES**

- 1. Adopt Resolution amending the City Council Rules of Procedure Section 5.5.5 to add a requirement for disclosure of receipt of salary or reimbursement of expenses from any Federal, State or local agency that has an item under consideration of the City Council.
- **2.** Take no action on the proposed Resolution.
- **3.** Provide alternate direction to staff.

#### **RESOLUTION 2016-74**

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, ADDING "GOVERNMENTAL AGENCY EMPLOYER" TO THE CONFLICT OF INTEREST AND DISCLOSURE SUBSECTION OF THE RULES OF PROCEDURE FOR COUNCIL MEETINGS AND RELATED FUNCTIONS AND ACTIVITIES

**WHEREAS**, Government Code Section 18700 provides that a public official has a prohibited conflict of interest and may not make, participate in making, or in any way use or attempt to use his or her official position to influence a governmental decision when he or she knows or has reason to know he or she has a disqualifying financial interest; and

**WHEREAS**, Government Code Section 87103(c) provides that a public official is disqualified from acting on any matter materially affecting any source of income (other than gifts or certain loans from a commercial lending institution) aggregating \$500 or more provided to, received by, or promised to the public official within 12 months before the time the decision is being made; and

**WHEREAS**, Government Code Section 82030(b)(2) provides that salary and reimbursement for expenses received from a federal, state or local government agency is exempt from the definition of "income" as used in Government Code Section 87103(c); and

WHEREAS, in order to promote ethical principles and full transparency, the City Council deems it necessary and appropriate to amend the Rules of Procedure for Council Meetings and Related Functions and Activities to require disclosure by a councilmember before participating in any proceedings involving any matter materially affecting his or her governmental agency employer.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Moreno Valley as follows:

#### Section 1. Recitals

That the Recitals set forth above are true and correct.

#### Section 2. Amendment to 5.5.5 "Conflict of Interest and Disclosure"

That Subsection 5.5.5 titled "Conflict of Interest and Disclosure" of Section 5.5 titled "Decorum and Order – Council Members" of the "Rules of Procedure for Council Meetings and Related Functions and Activities" shall be amended to add Section 5.5.5.5 as follows:

#### 5.5.5.5 Governmental Agency Employer.

A councilmember shall disclose his employment with a public agency prior to participating in any proceedings involving any matter materially affecting that governmental agency employer.

#### Section 3. Severability

That the City Council declares that, should any provision, section, paragraph, sentence or word of this Resolution be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Resolution as hereby adopted shall remain in full force and effect.

#### Section 4. Repeal of Conflicting Provisions

That all the provisions heretofore adopted by the City or the City Council that are in conflict with the provisions of this Resolution are hereby repealed.

#### Section 5. Effective Date.

That this Resolution shall take effect upon its adoption.

#### Section 6. Certification.

That the City Clerk shall certify to the passage of this resolution and enter it into the book of original resolutions.

#### **Recommendations: That the City Council:**

1. Consider, and if desired by a majority, approve the proposed Resolution of the City Council of the City of Moreno Valley, California, Adding "Disclosure of Campaign Contributions" to the Conflict of Interest and Disclosure Subsection of the Rules of Procedure for Council Meetings.

#### **SUMMARY**

This report presents proposed changes to the City Council Rules of Procedure, which if adopted would require disclosure of campaign contributions in excess of \$500 from direct or indirect sources who's interest would be materially affected by the item under City Council's consideration.

#### DISCUSSION

This staff report is being presented based on a request of two Council Members and as a follow up to the item presented to City Council at the meeting of September 20<sup>th</sup> by the Interim City Attorney.

Under current Council Rules of Procedure, Section 5.5.5.1 mandates compliance with applicable State laws with respect to Conflict of Interest disclosures. Government Code Section 84308 provides for disclosure and recusal from any decision affecting a campaign contributor in excess of \$250.00. The section however is not applicable to "local governmental agencies whose members are directly elected by the voters", meaning any city council or council members. Under State law there is no disclosure or recusal requirement related to campaign contributions for city council members.

The proposed Resolution in order to increase transparency of City Council's actions would amend the current policy to add a requirement of disclosure of any direct or indirect campaign contribution in excess of \$500.00 in an instance where an item before the Council would result in a material effect on such contributor. If adopted it would require a Council Member to announce that she/he received a contribution on excess of \$500.00 from the entity or person that has now an item before the Council. The change in policy would not require recusal.

#### **ALTERNATIVES**

- 1. Adopt Resolution amending the City Council Rules of Procedure Section 5.5.5 to add a requirement for disclosure of direct or indirect campaign contributions from a entity or a person that has an item under consideration of the City Council.
- 2. Take no action on the proposed Resolution.
- **3.** Provide alternate direction to staff.

#### **RESOLUTION 2016-75**

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORENO VALLEY ADDING "DISCLOSURE OF CAMPAIGN CONTRIBUTIONS" TO THE CONFLICT OF INTEREST AND DISCLOSURE SUBSECTION OF THE RULES OF PROCEDURE FOR COUNCIL MEETINGS

WHEREAS, in order to promote ethical principles and transparency in government the City Council of the City of Moreno Valley ("City Council") deems it necessary and appropriate to establish campaign contribution disclosure requirements pertaining to campaign contributions provided directly or indirectly to councilmembers; and

WHEREAS, elections at all levels of government have recently seen the growth of influence from political actions committees and other similar organizations that pool campaign contributions from members and donate funds to campaigns in support of or against local candidates; and

WHEREAS, this Resolution shall require that City Council Members must publically disclose a contribution, prior to considering or voting on any items involving an applicant that is an organization, vendor, contractor, consultant, business, or person, which has donated or contributed to the campaign of that City Council Member either directly or indirectly via a political action committee or other similar organization formed for the purpose of raising and spending money to elect or defeat local candidates.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Moreno Valley as follows:

#### Section 1. Recitals

That the Recitals set forth above are true and correct.

Section 2. Amendment to 5.5.5 "Conflict of Interest and Disclosure"

That Subsection 5.5.5 titled "Conflict of Interest and Disclosure" of Section 5.5 titled "Decorum and Order – Council Members" of the "Rules of Procedure for Council Meetings and Related Functions and Activities" shall be amended to add the following Section:

#### 5.5.5.4 Disclosure of Campaign Contributions.

**Direct campaign contributions.** Any councilmember who has received, within the prior 48 months, a campaign contribution of Five Hundred Dollars (\$500) or more, or a cumulative total of Five Hundred Dollars (\$500) or more, **directly** from a party or participant seeking any action or decision from the city council, during any given proceeding before the city council, shall disclose the nature of the campaign contribution.

Indirect campaign contributions. Any councilmember who has received,

Resolution No. 2016-75 Date Adopted: November 29, 2016 within the prior 48 months, a campaign contribution of Five Hundred Dollars (\$500) or more, or a cumulative total of Five Hundred Dollars (\$500) or more, **indirectly** from a party or participant seeking any action or decision from the city council, during any given proceeding before the City Council, shall prior to deliberation and vote: (a) disclose the nature of the campaign contribution.

"Indirectly" shall mean receiving a campaign contribution from employees or officers of the party or participant appearing before the subject proceedings or receiving a campaign contribution from a political action committee or similar organization organized for the purpose of raising and spending money to elect or defeat local city council candidates that has received contributions from the party or participant appearing before the subject proceedings.

#### Section 3. Severability

That the City Council declares that, should any provision, section, paragraph, sentence or word of this Resolution be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Resolution as hereby adopted shall remain in full force and effect.

#### Section 4. Repeal of Conflicting Provisions

That all the provisions heretofore adopted by the City or the City Council that are in conflict with the provisions of this Resolution are hereby repealed.

#### <u>Section 5</u>. Effective Date.

That this Resolution shall take effect upon its adoption.

#### Section 6. Certification.

That the City Clerk shall certify to the passage of this resolution and enter it into the book of original resolutions.




