RECOMMENDED ACTION

Recommendations:

- 1. Approve the Assignment and Assumption Agreement and Bill of Sale (Agreement) with Southern California Edison Company (SCE) for the transfer of assets associated with the Kitching Switchyard.
- 2. Authorize the City Manager to execute the Agreement with SCE on behalf of the City for the transfer of assets associated with the Kitching Switchyard.

<u>SUMMARY</u>

The Kitching Substation and Switchyard Project consists of two separate facilities; a substation that will be owned and operated by Moreno Valley Utility (MVU) and a switchyard that will be owned and operated by SCE. The switchyard serves as a point of connection between SCE's electrical transmission system and MVU's electrical distribution system.

This report recommends approval of an Assignment and Assumption Agreement and Bill of Sale with SCE for the transfer of assets pertaining to the Kitching Switchyard. The assets consist of all equipment, facilities, and appurtenances within the switchyard. Warranties for the major equipment within the switchyard will also be transferred through this Agreement. This item was presented to the Utilities Commission on September 27, 2017.

DISCUSSION

On December 12, 2016, the City Council authorized the bid award to High Country Line Construction, Inc. for the construction of the Kitching Substation and Switchyard project. The project is now substantially complete. Following a required testing and commissioning period, the anticipated date to energize the substation is November 3, 2017.

Pursuant to the Interconnection Facilities Agreement which was approved by City Council on September 6, 2016, as a requirement to interconnect with the SCE owned and controlled grid prior to energizing, the City is required to transfer ownership of the switchyard to SCE and to grant an easement to SCE for the purposes of owning and maintaining the equipment within the switchyard. The grant of easement of the switchyard to SCE was approved by City Council on May 16, 2017.

After the effective date of the Agreement, SCE will be solely responsible for the operation and maintenance of all equipment that is transferred to SCE with a manufacturer's warranty that includes full replacement and repair obligations being assumed by the manufacturer.

ALTERNATIVES

- 1. Approve the Assignment and Assumption Agreement and Bill of Sale and authorize the City Manager to execute the Agreement. *This will allow the switchyard and substation to be energized.*
- 2. Do not approve the Assignment and Assumption Agreement and Bill of Sale and do not authorize the City Manager to execute the Agreement. This alternative will delay energizing the switchyard potentially causing the City to be in non-compliance with its current Wholesale Distribution Access Tariff agreement.

FISCAL IMPACT

The cost of all interconnection facilities are being paid from a combination of the 2015 Lease Revenue Bonds and operating funds. Funds are available in account number 6011-30-80-80005-720199, project number 805 0027. There is no fiscal impact associated with the actual transfer of assets to SCE.

SOUTHERN CALIFORNIA EDISON COMPANY

(Kitching Street Project)

This Assignment and Assumption Agreement and Bill of Sale ("Agreement") is dated effective as of _______, 2017 ("Effective Date"), between the CITY OF MORENO VALLEY, a municipal corporation, County of Riverside, State of California (the "City") and SOUTHERN CALIFORNIA EDISON COMPANY, a California corporation ("SCE"). The City and SCE are referred to individually as a "Party" and collectively as the "Parties."

WHEREAS, on October 1, 2016, SCE and the City entered into an Interconnection Facilities Agreement ("IFA") which provides for the interconnection of the Kitching Street 115kV line, looping into SCE's existing Valley – Alessandro - Cajalco 115 kV line via a new 115 kV substation (the "Karma Substation"). The IFA was accepted on September 29, 2016 in Docket No. ER16-779-000 by the Federal Energy Regulatory Commission.

WHEREAS, for the purpose of minimizing construction costs and expediting the interconnection of the Project, SCE agreed, at the City's request, to allow the City to design, engineer, and construct the Karma Substation and the 115 kV line segment of the Valley – Alessandro – Cajalco 115 kV line from the Karma Substation (the "115 kV Line Segment"), and to subsequently transfer ownership of such facilities and the associated land and land rights, at no cost, to SCE. The 115 kV Line Segment and the Karma Substation include each of the items described in Attachment A (collectively, the "Facilities').

WHEREAS, the City has designed, engineered, procured, constructed and installed the Facilities in accordance with SCE's engineering, design, materials and construction standards, and, following completion of the Facilities' construction by the City, SCE has conducted its final inspection, testing and acceptance of the Facilities;

WHEREAS, the City executed that certain Grant of Easement dated May 23, 2017, which was recorded in the Official Records of Riverside County as Document 2017-0228696 on June 8, 2017, granting SCE the right to operate, maintain, repair and access a 115kV electrical substation on the site of the Karma substation;

WHEREAS, it is the desire of the Parties that title to, and possession of, the Facilities be transferred to and assumed by SCE, as of the Effective Date;

WHEREAS, in accordance with the IFA, the Parties shall concurrently execute this Agreement and a deed providing for the transfer of ownership of the Facilities, at no cost to SCE, which shall include all applicable warranties relating to the Facilities;

WHEREAS, SCE has provided its acceptance for transfer of ownership based upon its final inspection of the Facilities and field testing of the operation and maintenance of the Facilities;

WHEREAS, SCE is willing to accept and proceed with the transfer of ownership, operation and maintenance of the Facilities, and the City is willing to grant transfer of ownership, operation and maintenance to SCE;

NOW THEREFORE, in consideration of the mutual promises and covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. <u>Assignment and Sale</u>. Effective as of the Effective Date, the City hereby sells, transfers, conveys, and assigns to SCE the following:

- a. <u>Operating Personal Property</u>. Any and all of its right, title, and interest in and to all machinery, equipment, trade fixtures and other personal property used in connection with operating and maintaining the Facilities and located on or at the Karma Substation or the 115Kv Line Segment (collectively, the "Operating Personal Property");
- b. <u>Warranties</u>. Any and all warranties and guaranties including, without limitation, construction contractor's and manufacturer's warranties and guaranties, held by the City with respect to the Karma Substation, 115 kV Line Segment and/or Operating Personal Property (each, a "Warranty"); as listed on Attachment B hereto, and
- c. Plans, Specifications, Licenses and Permits. All plans and specifications, blueprints, engineering diagrams, as-builts, licenses, permits and similar items that relate to the Karma Substation, 115kV Line Segment and Facilities.
- 2. Assumption. Effective as of the Effective Date, SCE hereby accepts and assumes title to the Operating Personal Property. In accepting and assuming title to the Operating Personal Property, SCE does not assume, take subject to, nor shall be liable for, any liabilities or obligations of any kind or nature in connection with the Facilities arising before the Effective Date, whether absolute, contingent, accrued, known or unknown.

2. No other warranties or representations are assigned or granted to SCE by the City other than those Warranties assigned by the City pursuant to the IFA or this Agreement.

3. After the Effective Date, SCE shall be solely responsible for the operation and maintenance of the Facilities, subject to the terms of the IFA.

4. For all of the Facilities subject to a Warranty:

(a) The City shall notify the manufacturer in writing that SCE will be the sole owner of the Facilities, as of the Effective Date, and that all warranties provided by the manufacturer or construction contractor to the City will transfer to SCE as of the Effective Date;

(b) The City transfers all of its rights and obligations under the warranties, which the City believes to be in full force and effect based on representations of the vendors; and

(c) The City warrants and represents that no additional acts (including, but not limited to, any payment) are required in order for SCE to fully enforce any Warranty.

5. SCE shall be responsible for asserting warranty claims and other rights under the Warranties. The City shall assist SCE in enforcing any Warranty, and shall, upon receipt of written request by SCE, provide at no cost to SCE any additional documentation in its possession needed for SCE to make a claim under any Warranty.

6. The City warrants and represents that it is the lawful owner of the Operating Personal Property, that it has good and marketable title to the Operating Personal Property, free of any lien, claim, charge, security interest, or other encumbrance, and that it has the right to sell, transfer, and convey the Operating Personal Property and shall warrant and defend the title to the Operating Personal Property against all lawful claims and demands made against such property.

7. The City shall promptly execute and deliver all other instruments and documents and take all further actions as SCE may reasonably request to effectuate the transfer of title to the Facilities.

8. This Agreement is binding upon, and will inure to the benefit of and be enforceable by the Parties and their respective successors and assigns. The Parties do not intend to create rights in or to grant remedies to any third party as a beneficiary of this Agreement or of any duty, covenant, obligation or undertaking established in this Agreement other than the transfer of warranties as described above.

9. This Agreement may be executed by the Parties in counterparts which counterparts shall be construed together and have the same effect as if both Parties had executed the same instrument.

10. This Agreement shall be governed by, and construed in accordance with, the laws of the State of California without giving effect to the choice of law principles thereof, including all matters of construction, validity and performance.

IN WITNESS WHEREOF each of the undersigned has caused this Agreement to be duly executed by its authorized representative as of the Effective Date.



SIEMENS STANDARD TERMS AND CONDITIONS OF SALE FOR PRODUCTS

1. **APPLICABLE TERMS.** This Agreement governs the sale of equipment, components, parts, and materials provided by Siemens ("Products"). Any applicable addenda, these terms, Siemens proposal, price quote, purchase order, or acknowledgement issued by Siemens form the parties' final agreement ("Agreement"). In the event of a conflict between these documents, precedence shall apply in accordance with the order listed in the previous sentence. Siemens' proposal, offer or acceptance is conditioned on Buyer's acceptance of this Agreement. Any additional or conflicting terms in Buyer's request for proposal, specifications, purchase order or any other written or oral communication are not binding on Siemens unless separately signed by Siemens. Siemens' failure to object to Buyer's additional or conflicting terms does not operate as a waiver of any terms contained in this Agreement.

2. PRICING & PAYMENT. Prices and payment terms are: (i) as stated in Siemens' proposal, or if none are stated; (ii) Siemens' standard prices in effect when Siemens receives Buyer's purchase order; or if neither (i) or (ii) apply, then Siemens' standard prices in effect when the Products ship.

(a) *Payment.* Unless stated in Siemens' proposal, all payments are due net thirty (30) days from the invoice date in United States Dollars.

(b) *Credit Approval.* All orders are subject to credit approval by Siemens. Siemens may modify, suspend or withdraw the credit amount or payment terms at any time. If there is doubt as to Buyer's financial condition, Siemens may withhold manufacturing or shipment, require cash payments, or require other satisfactory security. Siemens may recover shipped Products from the carrier pending such assurances.

(c) Installment Shipment. Where Products are delivered in shipments or only part of a shipment fails to comply with this Agreement, the Buyer may only reject the non-compliant portion. Buyer will separately pay for each shipment. If Siemens holds or stores Products for Buyer, it shall do so at Buyer's sole risk and expense.

(d) Taxes, Shipping, Packing, Handling. Unless stated in writing by Siemens, Siemens' prices exclude charges for freight, unloading, storage, insurance, taxes, excises, fees, duties or other government charges related to the Products. Buyer will pay these amounts or reimburse Siemens. If Buyer claims a tax or other exemption or direct payment permit, Buyer will provide a valid exemption certificate or permit and indemnify, defend and hold Siemens harmless from any taxes, costs and penalties arising from same. Siemens' prices include the costs of its standard domestic packing only. Any packing deviation, including U.S. Government sealed packing, will be charged to Buyer. Increases, changes (including in application), adjustments or surcharges which may be incurred are for Buyer's account.

(e) Late Payments. Late payments shall bear interest at an annual percentage rate of twelve percent (12%) or the highest rate allowed by law, whichever is lower.

(f) Disputed Invoice. If Buyer disputes all or any portion of an invoice, it must first deliver written notice to Siemens of the disputed amount and the basis for the dispute within twenty-one (21) days of receiving the invoice. Failure of Buyer to timely notify Siemens of any dispute constitutes a waiver of Buyer's claim. If Buyer only disputes a portion of the invoice, Buyer must pay the undisputed portion in accordance with Article 2(a). Upon resolution of the dispute, Buyer must pay the invoice or the remainder of the invoice, plus any accrued interest on the late payment.

(g) Suspension/Termination Right. Siemens may suspend work if an undisputed invoice is more than thirty (30) days past due. Siemens may terminate this Agreement if an undisputed invoice is more than sixty (60) days past due. Unless prohibited by law, Siemens may also terminate this Agreement immediately in the event of a material adverse change in Buyer's financial condition including, but not limited to, bankruptcy, insolvency, liquidation or similar financial condition.

3. DELIVERY; TITLE; RISK OF LOSS. Products will be delivered F.O.B. Siemens point of shipment with title and risk of loss or damage passing to Buyer at that point. Buyer is responsible for all transportation, insurance and related expenses. The related expenses shall include any taxes, duties or documentation fees. Siemens may make partial shipments. Any shipping, delivery and installation dates are estimated dates only. Siemens is not liable for any loss or expense incurred by Buyer or Buyer's customers if Siemens fails to meet its delivery schedule.

4. DEFERMENT AND CANCELLATION. Buyer has no right to defer shipment but may cancel this Agreement on thirty (30) days written notice if Siemens has not already performed. If Buyer cancels this Agreement, it shall pay all cancellation charges including, without limitation: (i) the full price for any finished Product; (ii) for partially completed product, the portion of the price determined to be due by Siemens based on its percentage of completion of the Product; (iii) reasonable overhead and profit; and (iv) any payments due subcontractors and/or suppliers for any materials, components or products ordered which cannot be cancelled, refunded, or redirected for other beneficial use.

5. TRANSPORTATION AND STORAGE. (a) When Products are ready for shipment, Siemens will: (i) inform Buyer, and Buyer will then promptly give shipping instructions to Siemens; (ii) determine the method of transportation and shipment routing; and (iii) ship the Products with freight prepaid by normal transportation. If Buyer fails to provide timely shipping instructions, Siemens will ship the Products by normal transportation means to Buyer or to a storage location selected by Siemens. Buyer will pay or reimburse any excess transportation charges for special or expedited transportation.

(b) If Products are placed into storage, delivery occurs and risk of loss transfers to Buyer when the Products are placed on the carrier for shipment to the storage location. If the Products are to be stored in the facility where manufactured, delivery occurs and risk of loss transfers to Buyer when placed in the storage location.

Buyer will pay all Siemens' storage expenses, including but not limited to, preparation for and placement into storage, handling, freight, storage, inspection, preservation, maintenance, taxes and insurance, upon receipt of an invoice(s) from Siemens. When conditions permit and upon payment to Siemens of all amounts due, Buyer must arrange, at its expense, to remove the Products from storage. Buyer bears the risk of loss, damage or destruction to Products in storage.

6. FORCE MAJEURE / DELAYS. If Siemens' performance is delayed by any cause beyond its reasonable control (regardless of whether the cause was foreseeable), including without limitation acts of God, strikes, labor shortage or disturbance, fire, accident, war or civil disturbance, delays of carriers, cyber-attacks, terrorist attacks, failure of normal sources of supply, or acts or inaction of government, Siemens' time of performance will be extended by a period equal to the length of the delay plus any consequences of the delay. Siemens will notify Buyer within a reasonable time after becoming aware of any such delay.

7. BUYER'S REQUIREMENTS. Siemens' performance is contingent upon Buyer timely fulfilling all of its obligations under this Agreement. These obligations include the Buyer supplying all documents and approvals needed for Siemens to perform, including but not limited to technical information and data, drawing and document approvals, and necessary commercial documentation. Siemens may request a change order for an equitable adjustment in prices and times for performance, as well as for any additional costs or any delay resulting from the failure of Buyer or Buyer's contractors, successors or assigns to meet these obligations.

8. **INDEMNITY.** Siemens and Buyer (each as an "Indemnitor") shall indemnify the other ("Indemnitee") from and against all third party claims alleging bodily injury, death or damage to a third party's tangible property, but only to the extent caused by the Indemnitor's negligent acts or omissions. If the injury or damage is caused by the parties' joint or contributory negligence, the loss and/or expenses shall be borne by each party in proportion to its degree of fault. No part of the Product(s) or Buyer's site is considered third party property.

Indemnitee shall provide the Indemnitor with prompt written notice of any third party claims covered by this Article. Indemnitor has the unrestricted right to select and hire counsel and the exclusive right to conduct the legal defense and/or settle the claim on the Indemnitee's behalf. The Indemnitee shall not make any admission(s) which might be prejudicial to the Indemnitor and shall not enter into a settlement without the express permission of the Indemnitor.

9. WARRANTIES. (a) *Warranties*. Siemens warrants that: (i) each Product is free from defects in material and workmanship; (ii) each Product materially conforms to Siemens' specifications that are attached to, or expressly incorporated into this Agreement; and (iii) at the time of delivery, Siemens has title to each Product free and clear of liens and encumbrances (collectively, the "Warranties"). The Warranties do not apply to software furnished by Siemens. The sole and exclusive warranties for any software are set forth in the applicable Software License/Warranty Addendum.

(b) Conditions to the Warranties. The Warranties are conditioned on: (i) no repairs, modifications or alterations being made to the Product other than by Siemens or its authorized representatives; (ii) Buyer handling, using, storing, installing, operating and maintaining the Product in compliance with any parameters or instructions in any specifications attached to, or incorporated into this Agreement; (iii) compliance with all generally accepted industry standards; (iv) Buyer discontinuing use of the Product after it has, or should have had, knowledge of any defect; (v) Buyer providing prompt written notice of any warranty claims within the warranty period described below; (vi) at Siemens' discretion, Buyer either removing and shipping the Product or non-conforming part thereof to Siemens, at Buyer's expense, or granting Siemens reasonable access to the Products to assess the warranty claims; (vii) Product not having been subjected to accident (including force majeure), alteration, abuse or misuse; and (viii) Buyer not being in default of any payment obligation.

(c) Exclusions from Warranty Coverage. The Warranties do not apply to any equipment not provided by Siemens under this Agreement.

Any Product that is described as being experimental, developmental, prototype, or pilot is specifically excluded from the Warranties and is provided to Buyer "as is" with no warranties of any kind. Normal wear and tear is excluded, including any expendable items that comprise part of the Product (such as fuses, light bulbs and lamps). Siemens does not warrant or guarantee that any Product will be secure from cyber threats, hacking or similar malicious activity. Products that are networked, connected to the internet, or otherwise connected to computers or other devices must be appropriately protected by Buyer and/or end user against unauthorized access.

(d) *Warranty Period.* Buyer must provide written notice of any claims for breach of Warranties by the earlier of twelve (12) months from initial operation of the Product or eighteen (18) months from shipment. Additionally, absent written notice within the warranty period, any use or possession of the Product after expiration of the warranty period is conclusive evidence that the Warranties have been satisfied.

(e) *Remedies.* Buyer's sole and exclusive remedies for breach of the Warranties are limited, at Siemens' discretion, to repair or replacement of the Product, or its non-conforming parts, within a reasonable time period, or refund of all or part of the purchase price. The warranty on repaired or replaced parts is limited to the remainder of the original warranty period. Unless Siemens agrees otherwise in writing, Buyer will be responsible for any costs associated with: (i) gaining access to the Product; (ii) removal, disassembly, replacement, installation, or reinstallation of any equipment, materials or structures to permit Siemens to perform its warranty obligations; (iii) transportation to and from the Siemens factory or repair facility; and (iv) damage to equipment components or parts resulting in whole or in part from non-compliance by the Buyer with Article 9(b) or from their deteriorated condition. All exchanged Products replaced under this Warranty will become the property of Siemens.

(f) Transferability. The Warranties are only transferable during the warranty period and only to the Product's initial enduser.

NOTWITHSTANDING ANYTHING IN THIS AGREEMENT TO THE CONTRARY, SIEMENS IS NOT LIABLE, WHETHER BASED IN CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, INDEMNITY OR ANY OTHER LEGAL OR EQUITABLE THEORY, FOR: LOSS OF USE, REVENUE, SAVINGS, PROFIT, INTEREST, GOODWILL OR OPPORTUNITY, COSTS OF CAPITAL, COSTS OF REPLACEMENT OR SUBSTITUTE USE OR PERFORMANCE, LOSS OF INFORMATION AND DATA, LOSS OF POWER, VOLTAGE IRREGULARITIES OR FREQUENCY FLUCTUATION, CLAIMS ARISING FROM BUYER'S THIRD PARTY CONTRACTS, OR FOR ANY TYPE OF INDIRECT, SPECIAL, LIQUIDATED, PUNITIVE, EXEMPLARY, COLLATERAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, OR FOR ANY OTHER LOSS OR COST OF A SIMILAR TYPE.

SIEMENS' MAXIMUM LIABILITY UNDER THIS AGREEMENT IS THE ACTUAL PURCHASE PRICE RECEIVED BY SIEMENS FOR THE PRODUCT THAT GAVE RISE TO THE CLAIM.

BUYER AGREES THAT THE EXCLUSIONS AND LIMITATIONS IN THIS ARTICLE 10 WILL PREVAIL OVER ANY CONFLICTING TERMS AND CONDITIONS IN THIS AGREEMENT AND MUST BE GIVEN FULL FORCE AND EFFECT, WHETHER OR NOT ANY OR ALL SUCH REMEDIES ARE DETERMINED TO HAVE FAILED OF THEIR ESSENTIAL PURPOSE. THESE LIMITATIONS OF LIABILITY ARE EFFECTIVE EVEN IF SIEMENS HAS BEEN ADVISED BY BUYER OF THE POSSIBILITY OF SUCH DAMAGES. Siemens shall have the full and exclusive authority to defend and settle such claim(s) and will pay the damages and costs awarded in any suit or proceeding so defended. Buyer shall not make any admission(s) which might be prejudicial to Siemens and shall not enter into a settlement without Siemens' consent. Siemens is not responsible for any settlement made without its prior written consent. (c) It is Siemens' policy not to unlawfully or improperly receive or use confidential information, including trade secrets, belonging to others. However, Buyer shall not assign this Agreement to: a competitor of Siemens; an entity in litigation with Siemens; or an entity lacking the financial capability to satisfy Buyer's obligations. Any assignee expressly assumes the performance of any obligation assigned. Siemens may grant a security interest in this Agreement and/or assign proceeds of this Agreement without Buyer's consent.

18. APPLICABLE LAW AND JURISDICTION. This Agreement is governed by and construed in accordance with the laws of the State of Delaware, without regard to its conflict of laws principles. The application of the United Nations Convention on Contracts for the International Sale of Goods is excluded. BOTH SIEMENS AND BUYER KNOWINGLY, VOLUNTARILY AND IRREVOCABLY WAIVE ALL RIGHTS TO A JURY TRIAL IN ANY ACTION OR PROCEEDING RELATED IN ANY WAY TO THIS AGREEMENT. Each party agrees that claims and disputes arising out of this Agreement must be decided exclusively in a federal or state court of competent jurisdiction located in a state in which either Buyer or Siemens maintains its principal place of business. Each party submits to the personal jurisdiction of such courts for the purpose of litigating any claims or disputes.

19. SEVERABILITY. If any provision of this Agreement is held invalid, illegal or unenforceable, the remaining provisions will not in any way be affected or impaired. A court may modify the invalid, illegal or unenforceable provision to reflect, as closely as possible, the parties' original intent.

20. EXPORT / IMPORT COMPLIANCE. Buyer acknowledges that Siemens is required to comply with applicable export / import laws and regulations relating to the sale, export, import, transfer, assignment, disposal and use of the Products, including any export / import license requirements. Buyer agrees that Products will not at any time directly or indirectly be used, exported, imported, sold, transferred, assigned or otherwise disposed of in a manner which will result in non-compliance with any export / import laws and regulations. Siemens' continuing performance hereunder is conditioned on compliance with such export / import laws and regulations at all times.

21. PRODUCT RETURNS. Prior to the return of any Product to Siemens, Buyer must identify the Product or portion thereof and obtain written authorization and shipping instructions from Siemens. Siemens has the right, in its sole discretion, to permit or reject any such return. Siemens' authorization to return any Product to Siemens does not relieve Buyer of its obligation to pay for such Product. Upon receipt, inspection, and acceptance of the Product by Siemens, Siemens will issue a credit memo to Buyer, less applicable re-stocking fees. Siemens reserves the right to reject any hazardous material.

22. NUCLEAR. Unless expressly authorized in writing by Siemens, the Products must not be used in or in connection with a nuclear facility or application. If Buyer uses any Product in connection with any nuclear facility or activity, it does so at its own risk and Buyer will indemnify, defend and hold Siemens harmless, and waives and will require its insurers to waive all right of recovery against Siemens for any damage, loss, destruction, injury or death resulting from a "nuclear incident," as defined in the Atomic Energy Act of 1954, as amended, whether or not due to Siemens' negligence. Siemens' consent to Buyer's use of the Product in connection with any nuclear facility or application will be subject to additional terms and conditions that Siemens deems necessary to protect its interests.

23. SURVIVAL. The articles titled "Patent and Copyright Infringement," "Limitation of Liability," "Confidentiality," "Delivery; Title; Risk of Loss," "Export / Import Compliance," and "Nuclear" survive termination, expiration or cancellation of this Agreement.

RECOMMENDED ACTION

Recommendations:

- 1. Approve 115kV Service Agreement for Wholesale Distribution Service between the City of Moreno Valley and Southern California Edison Company (SCE).
- 2. Authorize the City Manager to execute the Agreement on behalf of the City of Moreno Valley.

<u>SUMMARY</u>

Moreno Valley Utility (MVU) uses a portion of SCE's transmission and distribution system to bring power to and serve MVU customers. The Service Agreement for Wholesale Distribution Service describes the terms and conditions under which MVU can connect to SCE's system; an approved Agreement is required at each point that MVU's system connects to SCE's system. MVU is currently connected to SCE at seven locations in the City; this Agreement is for the Kitching Substation, located in the south industrial portion of the City. This report recommends approval of the Service Agreement for Wholesale Distribution Service.

This item was presented to the Utilities Commission on September 27, 2017.

DISCUSSION

The rapid growth of large commercial projects in the south industrial area has created the need to expand capacity by constructing a 115kV substation. The Kitching

ID#2789

Substation Project was approved by the City Council on May 26, 2015. The Kitching Substation and associated circuits are funded through a combination of the 2015 Lease Revenue Bonds and operating funds.

MVU applied for an 115kV interconnection to SCE's system in December 2014. Two agreements with SCE are required to complete an interconnection to SCE's system; an Interconnection Facilities Agreement (IFA) and a Service Agreement for Wholesale Distribution Service. The Agreements are prepared after a study is completed by SCE that analyzes the impact of an interconnection on their system. The IFA provides the terms and conditions for SCE to design, purchase, construct, own, operate, and maintain the facilities necessary for MVU to connect to SCE's system. The IFA was approved by the City Council on September 6, 2016.

The Service Agreement for Wholesale Distribution Service describes the terms and conditions to allow MVU to connect to SCE's system at 115kV. Under this Agreement, SCE will allow MVU to connect to SCE's system at a monthly cost of \$0.90 per kW and a customer charge of \$7.00. The Agreement will remain in effect until the City provides six months advance written notice of termination.

ALTERNATIVES

- 1. Approve the Service Agreement for Wholesale Distribution Service. Staff recommends this alternative because execution of this Agreement is necessary to energize the substation. Completion of the Kitching Substation is critical to meet projected electrical demand in the south industrial area.
- 2. Do not approve the Service Agreement for Wholesale Distribution Service. Staff does not recommend this alternative because it will impair the utility's ability to efficiently and reliably serve customers in the south industrial area.

FISCAL IMPACT

Funds in the amount of \$1,240,000 are available in account 6010-30-80-45510-710114 for the monthly charge, which is anticipated to begin in November 2017.

4. Service under this Service Agreement shall commence on the later of (1) <u>November 3</u>, <u>2017</u>, or (2) the date on which construction of any Direct Assignment Facilities and/or Distribution System Upgrades specified in Sections 7.0 and 8.0 of the attached Specifications For Wholesale Distribution Service are completed and all additional requirements are met pursuant to Section 13.5 of the Tariff, or (3) such other date as it is permitted to become effective by the Commission. RECOMMENDED ACTION

Recommendations:

- 1. Authorize the City Manager or her designee to contract with Hitachi Data Systems for video storage and professional services in an amount not to exceed \$92,206.10.
- 2. Authorize the budget adjustments listed in the Fiscal Impact section to transfer funding for this project from Technology Services depreciated asset accounts to Technology Services operating accounts.
- 3. Authorize the City Manager or her designee to execute any subsequent related change orders to the contract up to, but not exceeding, a 10% contingency amount of \$9,220.

<u>SUMMARY</u>

This report recommends authorizing a budget adjustment and contracting with Hitachi Data System (HDS) to purchase equipment and professional services to expand the storage capacity of the Citywide Camera System (CCS). Funding for this project comes from depreciated CCS assets, thus no new funding is requested; however, authorization to transfer equipment replacement funding to operating expenses is needed. This purchase from HDS is based on a sole source provision since the servers and storage for the Citywide Camera System operate exclusively on HDS equipment.

BACKGROUND

ID#2791

Page 1 Packet Pg. 141 In August 2012, the City Council awarded a contract and a five (5) year support agreement to HDS following a Request for Proposals (RFP) process. The award capped an extensive review of camera systems at other jurisdictions and a competitive proposal process from vendors nationwide. During the fourth quarter of 2011 and the first quarter of 2012, Police and City Staff reviewed camera systems and met with representatives from several Southern California cities concerning their camera systems. After evaluating various camera systems, City Staff determined that a citywide camera system would enhance the law enforcement capabilities of the Moreno Valley Police Department and enable other City Departments to benefit from CCS.

CCS started with 258 cameras, has grown to approximately 430 cameras, and is considered an invaluable tool by City departments. Growth in the number of cameras, thus storage needed for the videos, coupled with the age of the servers necessitates an upgrade that will maximize the storage capacity of the newest server so that cameras on old servers can be transferred to the newer server. This consolidation of storage to new servers will allow the older equipment to be retired, which is consistent with the City's ongoing efforts to minimize annual support costs.

After awarding the contract in August 2012, the City executed a Direct Purchase Agreement (Master Agreement) with HDS and all subsequent purchases from HDS take the form of accepting additional Customer Quotations. Thus, authorizing this contract to HDS will only require that the City accept Customer Quotation number 20022033-3 in Attachment 1.

CCS has proven to be extremely valuable to several Departments and has grown 67% in four years. The original servers and storage are not sufficient to continue to service the present workload. Several new servers and some new storage were purchased in January. However, continued growth of CCS requires that additional storage capacity.

Staff recommends that expansion of the Citywide Camera System be performed by HDS as a sole source provider (City Procurement Policy #3.18, Section V, Paragraphs A.8 & 9). Since the system was designed and built by HDS using HDS equipment after a competitively bid process, the expertise to enhance that system is uniquely held by HDS. Additionally, the City is approximately four years into a 5-year agreement with HDS to provide maintenance for the system. HDS' knowledge of the complete system, how it works and how to enhance it, provides significant and unique value to the City of Moreno Valley in operating this proprietary system.

ALTERNATIVES

1. Authorize the City Manager or her designee to contract with Hitachi Data Systems for video storage and professional services for an amount not to exceed \$92,206.10; authorize the recommended budget adjustments to transfer asset replacement funding to Technology Services operating accounts; and authorize the City Manager or her designee to execute any subsequent related change orders to the contract up to, but not exceeding, the 10% contingency amount of

\$9,220. Staff recommends this alternative to consolidate and enhance the Citywide Camera System while also reducing support costs.

2. Do not authorize a contract with Hitachi Data Systems, nor authorize the budget adjustments. *Staff does not recommend this option as it would hinder expansion and operation of the Citywide Camera System.*

FISCAL IMPACT

Funding for this project is available via the Technology Services Asset Replacement fund. The recommended actions will not impose additional General Fund costs.

RECOMMENDED ACTION

Recommendations:

- 1. Approve and adopt the proposed resolution to accept all right, title, and interest to a reconstructed portion of Nason Street south of State Route 60 upon relinquishment from the State of California.
- 2. Authorize the Mayor of the City of Moreno Valley to sign the proposed resolution and direct the City Clerk to certify said resolution and transmit a copy to the State.
- 3. Approve the waiver of the State's obligation to provide 90-days notice prior to the State's intention to relinquish to the City as set forth in Section 73 of the California's Streets and Highways Code.

SUMMARY

This report recommends approval of a resolution to accept a portion of Nason Street between State Route (SR) 60 and Fir Avenue. Conveyance from the State of California (State) to the City was intended as part of the street right-of-way transfer upon completion of the Nason Street/SR-60 Interchange project.

DISCUSSION

The Capital Projects Division of the Public Works Department has recently completed

the construction of the Nason Street/SR-60 Interchange project from Fir Avenue on the south to Elder Avenue on the north. This project reconstructed the overcrossing bridge, widened Nason Street, shifted the freeway ramps, and completed related work. The project has enhanced safety and increased travel times for residents and commuters.

The project was performed in two phases. The first phase required straightening the old-style curved on- and off- ramps to join Nason Street at a more northerly point just south of the new bridge. Shifting the ramps northerly allowed the former ramp area to be determined excess (extra) land to the State, with the exception of the area needed for the widening of Nason Street to four lanes. This report allows the City to accept the ownership of Nason Street in fee, as well as accepting easements for a parallel embankment slope and drainage channel on the west side of Nason Street. The distance along Nason Street is approximately two hundred eighty (280) feet. The State has already sold the remaining excess ramp area that is not needed for the street to an adjoining owner.

The State is also requesting waiver of their obligation to provide 90-days prior notice of their intention to relinquish the property to the City, as required in the California Streets and Highways Code Section 73. Since this report will be published as a City agenda item, staff recommends the City agree to the State's waiver of a 90-day notice when the State performs their relinquishment. The relinquishment is a separate, later action No. 496-R by the California Transportation Commission, and is the final step in conveying the right-of-way to the City. Allowing the waiver would expedite the final conveyance to the City.

Staff is recommending the City Council adopt the proposed resolution.

Approval of the recommended actions would support Objective 4 of the *Momentum MoVal* Strategic Plan: "Manage and maximize Moreno Valley's public Infrastructure to ensure an excellent quality of life, develop and implement innovative, cost effective infrastructure maintenance programs, public facilities management strategies, and capital improvement programming and project delivery."

ALTERNATIVES

- 1. Approve and direct the recommended actions as presented in this staff report. *This alternative will allow for the acceptance of rights for the Nason Street/SR-60 project.*
- 2. Do not approve and direct the recommended actions as presented in this staff report. *This alternative will delay the completion of the Nason Street/SR-60 right of way conveyances.*

FISCAL IMPACT

The recommended actions have minimal fiscal impact to the City. The City already maintains Nason Street and associated features per agreement with Caltrans. This



action slightly increases the physical area of City maintenance; however, the cost is offset by the improved access and reduced vegetation at this location.

- 1. To approve by resolution: acceptance of all right, title and interest to the portion of Nason Street as depicted in Exhibit A .
- 2. To authorize the Mayor of the City of Moreno Valley to sign said resolution and direct the City Clerk to attest to the same.
- 3. To waive, per Section 73 of the Streets and Highways Code, the STATE'S obligation to provide notice of "Intention to relinquish" 90 days prior to the actual relinquishment to the CITY.



RECOMMENDED ACTION

Recommendations: That the City Council:

- 1. Conduct a Public Hearing to allow public comment on the proposed Substantial Amendment #1 to the FY 2017-2018 Annual Action Plan.
- 2. Review and adopt the proposed Substantial Amendment #1 to the FY 2017-2018 Annual Action Plan.
- 3. Authorize a budget amendment as set forth in the fiscal impact section and authorize the Chief Financial Officer to allocate grant funds between HUD-approved grant activities.

SUMMARY

This report recommends that the Council conduct a Public Hearing to update the FY 2017-18 Annual Action Plan to add one program funded by the Emergency Solutions Grant (ESG) for homeless outreach and intake services and one program funded by the Community Development Block Grant (CDBG) for neighborhood cleanup, both in partnership with the Salvation Army. The amendment to the Action Plan would provide additional resources for homeless outreach efforts along with clean up and beautification projects within the CDBG project area. The pledging of grant dollars will help the City to meet the commitment and expenditure deadlines as imposed by the Office of Housing and Urban Development (HUD), while providing these critical services. The allocation of the ESG funds has been made available from the previously approved allocation of the CDBG funds will not impact any projects, as previously

approved by the City Council. The combination of these two programs will be the foundation of the City's Homeless to Work program, with the Salvation Army. The comprehensive Homeless to Work program would help prepare participants to transition to the active workforce by providing temporary employment while connecting them with social service resources to help overcome obstacles to their pursuit of gainful employment and permanent housing.

DISCUSSION

On September 5, 2017, the City Council provided the initial direction for the development of a Homeless to Work pilot program. The Salvation Army was the only nonprofit which expressed interest in the program and submitted a written request to participate as the community nonprofit partner to administer the program. Based on the Salvation Army's past experience with HUD funded programs and providing services to the homeless, it is recommended to move forward with this partnership. Additionally, the Salvation Army will be able to provide \$80,000 of in-kind support for the program as required for the ESG grant and they have additional personnel resources to assist in providing proper support for the homeless workforce.

As a recipient of federal grant funding, the City of Moreno Valley completes a five-year Consolidated Plan and an Annual Action Plan Update that details the use of the grant funds issued to the City by the Department of Housing and Urban Development (HUD). Federal law requires that in cases where there are substantial changes to an approved Plan that cities notify its citizens of the proposed amendment(s) and provide them the opportunity to comment by holding a Public Hearing, then submitting the Council-approved 'Substantial Amendment(s)' to HUD for final approval.

This staff report requests the City Council approve the amendment to add the comprehensive Homeless to Work program to the Action Plan.

The structure for Moreno Valley's pilot program is proposed to address the needs of homeless individuals in our community, while effectively leveraging governmental, social service and non-profit resources. As with other agencies' homeless programs, the City's Homeless to Work program would provide a pathway out of homelessness through work opportunities, community collaboration and assistance with access to existing housing, health care, and employment services. To be successful, the program should be a collaborative effort between the City, County, Salvation Army, and regional nonprofit groups and organizations. The following is a proposed program structure:

Program

Operation: The Council's approval of the actions recommended in this report will allow staff to enter into a contractual arrangement through which the Salvation Army will operate all aspects of the employment program. This structure maximizes the benefit of partnering with a non-profit agency with specialized experience in working with the target population, as well as the agency's successful track record for linking at-risk individuals with social

service resources to help overcome obstacles to their pursuit of gainful employment and permanent housing.

Program Funding:

ESG (Homeless Outreach) – Through the ESG funding, the Salvation Army will be focused on providing homeless outreach services which may include pickup of individuals; transportation; intake and assessment; input of data into the Homeless Management Information System (HMIS); case management; assistance with obtaining driver's licenses, identification cards, social security cards; and providing referrals to other non-profit as necessary for assistance and vouchers. <u>The proposed ESG budget is \$80,000 for this program</u>. The Salvation Army will also be required to provide 100% in-kind match to the grant award.

CDBG (Project Area Cleanup) – CDBG funding will be used to provide interim assistance to areas with determinable signs of physical deterioration when the improvements are intended to arrest deterioration prior to permanent improvements being made or when the activity will alleviate conditions threatening public health and safety. The Salvation Army would perform cleanup and beautification efforts within the CDBG project area. These efforts may include collecting and clearing litter, debris, including clearing dead brush and grasses. They will assist by identifying areas within CDBG project area right-of-ways and parks, which require assistance. The proposed CDBG budget is \$30,000 for this program.

Private donations, perhaps via partnership with private sector community stakeholders, could augment resources available for delivery of these services. Waste Management has indicated a strong interest in supporting the program.

Temporary

- Employment: On an as needed basis, up to five participants may work two days per week, 5 hours per day, at a rate of \$10.50 per hour (to be adjusted in accordance with minimum wage rules).
- Work Tasks: Tasks will not require specialized training, use of heavy equipment or exposure to potentially hazardous materials. Work assignments would be designed by the City, focusing entirely upon enhancement of public property. Activities would include collecting and clearing litter and non-hazardous debris, including clearing dead brush and grasses in locations such as maintenance of public right-of-way areas, parks and other City-owned public areas within the CDBG project area.

- Program Staffing: A driver/site supervisor, provided by the Salvation Army, would provide orientation for daily workers, monitor work and assist as needed. Additional nonprofit staff will be available for initial intake form processing and to provide resources for immediate connection to County services, housing programs, etc.
- Transportation: The Salvation Army will provide a passenger van to be used for transporting individuals to/from the job sites and service locations.

Meals/Nutrition: A sack lunch and water shall be provided by the Salvation Army.

Although Moreno Valley's homeless population is smaller than what is found in many other cities, a Homeless to Work program would position this City as a regional leader in taking innovative steps to help preclude and/or reduce homelessness in our community. Experience and results obtained through this program would benefit program participants as well as partner agencies in identifying effective methods of providing meaningful assistance to those in need.

If Council chooses to approve these programs, it would not only assist the City to meet its upcoming grant commitment deadlines but also its future expenditure deadlines. It would improve the homeless outreach and support efforts within the 5-Year Consolidated Plan, but most importantly, it would provide additional homeless outreach and community beautification efforts.

ALTERNATIVES

<u>Alternative 1</u>. Conduct the Public Hearing, adopt Substantial Amendment #1, affecting ESG and CDBG, to the FY 2017/18 Annual Action Plan; and authorize the Chief Financial Officer to allocate grant funds between HUD-approved grant activities. *Staff recommends this action because it complies with HUD's substantial amendment requirements, would allow for the City to better meet the commitment goals established for the ESG and CDBG Programs, assist to meet future spend down requirements, and add to the resources available to the homeless and CDBG project area.*

<u>Alternative 2:</u> Decline to adopt Substantial Amendment #1, affecting the HOME to the FY 2017/18 Annual Action Plan; and not authorize the Chief Financial Officer to allocate grant funds between HUD-approved grant activities. *Staff DOES NOT recommend this action because it would not allow the City to meet program goals established for the ESG and CDBG Programs, would not allow funds to be fully allocated, and would not direct additional available resources to benefit homeless individuals and the CDBG project area.*

FISCAL IMPACT

The allocation of the ESG funds has been made available from the previously approved allocation by the City Council to PW Enhancements which has declined its award. The allocation of the CDBG funds will not impact any projects, as previously approved by the City Council. **This amendment would have no impact on the General Fund**.
