RECOMMENDED ACTION

Recommendation that the City Council:

- 1. Cancel the Regular Council Meeting of December 4th, 2018.
- 2. Schedule a Special Council Meeting for December 11th, 2018 at 6:00 pm.

<u>SUMMARY</u>

Due to the delay in certification of election results by the County Registrar of Voters (ROV), staff is recommending that the first Council Meeting in December be changed from December 4th to December 11th, 2018.

DISCUSSION

Historically, newly elected Council Members have been sworn in and take office at the first meeting in December, or as soon as legally permitted after the election. Such was going to be the case this year as the election results were expected to be certified on or before December 4th. However, on November 14th, the City Clerk received a notification from the Registrar of Voters Office, advising the City that the certification would not be issued until December 6th, 2018 or after that date.

Consequently, in order to seat the new Council Members as soon as possible without requiring an additional (third) Council Meeting in December, staff recommends that the

City Council cancel the December 4th, 2018 meeting and schedule a special meeting for December 11th, 2018 at 6:00 p.m. At that meeting, assuming that ROV has certified election results, the newly elected officials can be sworn in and take their seats on the dais. Items scheduled for the December 4th meeting would be agendized for the Council's consideration on December 11th. The second regular Council Meeting in December will take place as scheduled on December 18th, 2018.

ALTERNATIVES

- 1. City Council can follow staff's recommendation and cancel and reschedule the December 4th Regular Meeting to a Special Meeting on December 11th, 2018. *Staff recommends this alternative.*
- 2. City Council can make no changes to the December Regular Meeting schedule an additional (third) Meeting in December when election results are certified by the County. *This alternative is not recommended by staff, due to additional costs and lack of efficiency.*
- 3. Provide alternate direction to staff.

FISCAL IMPACT

If selected, staff's recommendation will provide cost savings and efficiencies by precluding the need to schedule a third Council Meeting in December.
