Council Member Cabrera asked the terms of revenue with all the uses, which use provides the most revenue in terms of taxes, and the least revenue?

Chief Financial Officer Eyerman stated there is no revenue at this point only cost recovery and no proposed revenues within fees currently.

Council Member Marquez inquired if a Council Member at any time lessen the 600 foot buffer that is required by State guidelines currently?

Senior Planner Gross concurred that the 600 foot buffer is part of the State guidelines and is being established as the City's buffer.

INTRODUCE by title only and conduct the first reading of Ordinance No. 932 entitled "An Ordinance of the City Council of the City of Moreno Valley, California, amending sections 9.02.030 "Permitted Uses" and 9.15.030 "Definitions" and adding Section 9.09.290 "Commercial Cannabis Activities" to Title 9 of the Moreno Valley Municipal Code, establishing land use regulations for operation of commercial cannabis dispensaries, testing, cultivation, manufacturing, microbusinesses, distribution centers and related cannabis activities."

At the Commission meeting, the Board approved an expansion of the Freeway Service Patrol (FSP) to include weekends. The FSP is a roving team of tow trucks traveling selected Riverside County freeways to assist motorists with car trouble. The operators can assist with flat tires, dead batteries, and vehicles that run out of fuel. As part of an overall plan to improve transportation throughout Riverside County, the FSP operates as a joint venture between Caltrans, CHP, and RCTC. The Riverside Transit Agency is having another Youth Summer Fare promotion from June 1, 2018 through September 3, 2018. Students must show a school-issued ID card from the most recent school year, an RTA Youth ID card, or a California driver's license or state ID showing their age as 18 years old or younger. In addition, members of the public are invited to join Transportation NOW (T-NOW) to promote public transportation. T-NOW includes elected officials, community advocates, and transit riders.
