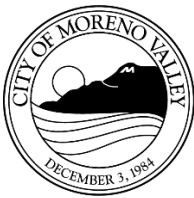

### **RECOMMENDED ACTION**

Staff recommends that the Senior Citizens' Advisory Board (S.C.A.B.) receive and file this program update.

### **SUMMARY**

- Senior Center attendance February 2024: 3,147 averaging 157 per day (January, 3,218)
- Senior Center membership end of February 2024: 3,360
- Meals delivered February 2024: 2,000 meals to 400 seniors, averaging 100 seniors per week.
- Hot lunches served February 2024: 1,785, averaging 89 per day (January 1,882)
- FSA has implemented new take home meals on weekends for seniors. Date TBA.
- Feeding America distributed (# not in at time of report) non-perishable food boxes on March 14, 2024, Senior Center continues to lead the I.E., in boxes distributed to seniors.
- The Center continues will operate as a warming center when temperatures drop below 35 degrees.
- The Center's banquet room continues to average two banquet rentals a month and two church rentals every Sunday.
- Healthcare agencies are available at the Center to discuss health care options, open enrollment has ended.
- Friends of Moreno Valley continues its partnership with the Salvation Army to provide 36 seniors with perishable food items. Distribution will be every Friday.
- Friends continues providing free shuttle service to seniors for all medical and grocery needs as well as free coffee.
- Haircuts continue to be full at the Senior Center every other Tuesday. Appointment required.
- Information for requesting translation services has been added to the monthly calendar.
- UbiDuo was available during voting.
- New equipment was available for translation at the March Townhall Meeting.
- AARP Taxes services end on April 15.
